CONTINUUM OF CARE

Level of Care Assessment

A face-to-face evaluation of the client to ascertain the degree and severity of alcohol and other drug use in order to determine the appropriate services and/or treatment modality.

Case Coordination

An individualized service designed for individuals with substance use disorder who have ancillary treatment and non-treatment needs. Activities include assessment/evaluation, linking to community services and supports, engaging clients who have a pattern of non-compliance, service planning, goal setting, advocating for services and resources, and follow-up to ensure needs were addressed.

Certified Recovery Support Services

Offer guidance to individuals struggling with addiction through the shared experience of a mutually supportive relationship with another individual who has personal experience with a journey of recovery.

Outpatient Counseling

Individual, group, or family therapy provided in an office setting by an individual or group of individuals who are licensed psychologists, social workers, credentialed counselors, or certified addictions counselors and allied addictions practitioners.

Intensive Outpatient Services

These programs generally provide 9-19 hours of structured programming per week for adults consisting primarily of counseling and education about addiction-related and mental health problems.

Partial Hospitalization Program

These programs generally feature 20 or more hours of clinically intensive programming per week for individuals with substance use disorders.

Medication Assisted Treatment

Medications utilized in conjunction with any level of care to assist with substance use treatment.

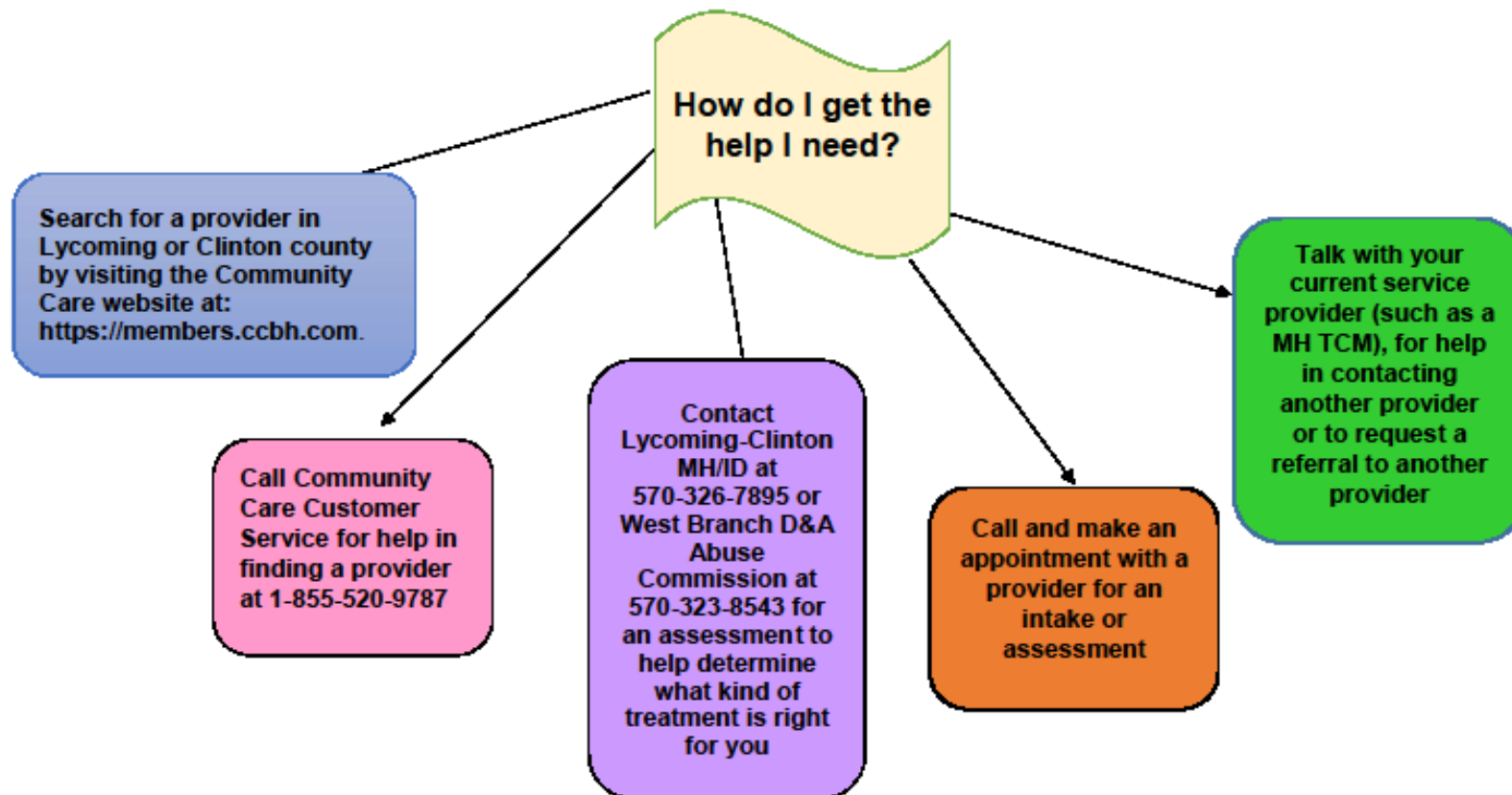
